## Bank Standing Order

This is the preferred method currently used by over 100 members of the congregation, and greatly assists the Treasurer for budgeting purposes. You can either complete a form (available at the back of this booklet) or set one up online if you use online banking. You are in control and can set one up to make a regular donation weekly, monthly, quarterly or annually, and can increase or decrease amounts as circumstances dictate.

## Regular Giving Online

You can donate online to the church via our ChurchSuite software using GoCardless. This can be done via our church website:

or via ChurchSuite by selecting the My Giving tab in the menu. If you don't have access to ChurchSuite, please speak to Saira ([sairafinal@allssaintseastbourne.com](mailto:sairafinal@allssaintseastbourne.com)).

You can make one-off, weekly or monthly payments through this system.

You can also set this up by SMS (see overleaf).

## Cash or card on Sundays

You can give by cash in one of the baskets at the entrance or exit of church, or use one of the Giving Envelopes to make a one-off donation. You can also use our contactless card readers (Tap & Go) to give amounts between £5-£100.

## SMS Giving (for Smartphones)

You can donate to the church by sending an SMS (text message) to **07380 307 800** starting with our keyword **ASC**, followed by the amount you'd like to give. If you'd like to set up a weekly or monthly donation the amount should be followed by 'w' or 'm'.

For example, **ASC give 10** for a one-off £10 donation, or **ASC give 10m** for a £10/month recurring donation. You will receive a reply with a link to an online form pre-filled with the information you have given. You can now review your donation and enter your card or bank account details to make the payment.

## Credit or Debit Card

You can make one-off donations by debit or credit card via our partnership with **Sum-Up**. Please speak to our Treasurer, Andy Anderson to organise this.

## Easyfundraising

Easyfundraising works with over 7000 brands to donate part of what you spend to charities when you shop online. It won't cost you any extra.

## Legacies and Wills

Leaving All Saints' Church a gift in your Will is a lasting way to support our Church in its mission and ministry within our local community. Once you have made provision for your loved ones, you have the opportunity to make a lasting gift to God by leaving a legacy to His church.

### What do I need to know if I want to leave a gift in my Will?

We recommend you use a solicitor or qualified Will writer, who will be able to include this information alongside the type and amount of your bequest to us. There are several local solicitors who offer this service.

You can also amend or add to your existing Will by means of a **Codicil**, which is normally cheaper than writing a full Will. Any solicitor would recommend that you also look into **Lasting Power of Attorney** if you have not already done so.

By using a professional adviser, this ensures not only that your estate is distributed as you would wish, but also that you have minimised your taxable contribution, leaving more for those you care about and good causes.

## What sort of gift can I leave in my Will?

A donation to All Saints' in your Will is a great way to leave something behind to continue to secure our mission to bring the wonderful light of Jesus into our local community. Whether you give a little or a lot, your donation will help us to keep on with our life changing mission.

### Types of gifts:

A gift of an object or contents of a property.

A gift of a specific sum of money (this is also known as a pecuniary legacy).

Leaving a share of the rest of your estate once you have remembered the needs of those you have loved and who have supported you in your lifetime (also known as a residual legacy).

Your gift can be to a specific area of church life (i.e. Youth Work or The Organ Fund) or can be unspecified and go into church general funds to be used at the discretion of the PCC.

## **Gift Aid**

If you are a UK taxpayer, the Government's Gift Aid scheme allows charities to claim an extra 25p for every £1 you donate.

Please use the forms attached to let us know that we can claim Gift Aid on your donations. There is a separate form for one-off donations and regular donations.

Please note: you must be paying more Income Tax/  
Capital Gains tax than the amount of Gift Aid claimed on all donations in that tax year.
